**INFORMATION FOR ALL RETIREES REQUESTING EXTENSION OF THEIR
TRANSPORTATION ENTITLEMENT**

IMPORTANT INFORMATION:

If you have executed a move using your retirement orders and settled a travel claim, you may not be entitled to a move using those same retirement orders. If any additional move(s) are executed on your retirement order all cost is the responsibility of the retiree.

1. All retirees submitting a request for their extension of transportation entitlement to the Joint Personal Property Shipping Office at Fort Belvoir, VA must adhere to the following:

a. A written request must include the following information:

- A valid reason as defined per the Joint Federal Travel Regulation (JFTR), paragraph U5365.
- A current address where you are residing.
- Home/Work/Cell phone number.
- Email address
- Copy of your retirement orders

b. Submission of your request:

- The JPPSOWA is going paperless. We recommended the request be sent via email to: "Sherman.sherin@conus.army.mil", with a copy of your retirement orders.
- If you missed the required suspense date for submission, the JPPSOWA does not have the authority to reinstate your entitlement. It must go to the Secretary of the Army. You must submit a "Request for Reinstatement" with an explanation as to why your reinstatement request should be considered. Please submit the memorandum as shown below:

2. For all other services (Navy, Air Force, and Marines), see attachment. The attachment ("Retirement Extensions") provides information for where to send your requests, or call for other information regarding your retiree transportation entitlement.

NOTE 1: In the instances that you are not able to email your request to the JPPSOWA, you can fax your request (including your retirement orders) to fax#: (703) 806-0144, ATTN: Mr. Sherin, or mail your request to the JPPSOWA address above. You can call (703) 806-0771 to confirm receipt of your faxed or mailed request. We stress that we greatly prefer an e-mailed request from the customer, not a fax or a letter request, as we are trying to go paperless.

NOTE 2: Other information regarding retiree transportation entitlements based on the JFTR, Vol. 1 can be accessed through the JPPSOWA website at <http://www.belvoir.army.mil/jppsowa>. Once there, select "FAQ" (Frequently Asked Questions) and look for the retiree entitlement questions.

NOTE 3: There are only 2 documents required when requesting extension of your transportation entitlement: your request in writing, and a copy of your retirement orders. There is NO requirement for a copy of your DD form 214. This document does not provide any entitlement to your transportation or travel.
