

Retirees Transportation Entitlement and Extension: Retirees from the **Navy** and **USMC** (for 1st Year entitlements) requesting extension of their Transportation Entitlement must submit their request to the JPPSO-MA via email ONLY to lenora.a.reeves.civ@mail.mil. All **Army** requesting extension or reinstatement of their transportation entitlement must submit their request to the JPPSO-MA via email only to lenora.a.reeves.civ@mail.mil. All requests to be submitted must have a reason for the extension, and a copy of the retirement orders (including amendments), and/or a copy of the last approved extension must be provided.

NOTE: Per JTR (1 Oct 14); Chap 5, PDT, Part A, Uniformed Services ONLY, Sec 2c, par 5068 B1 (General): Except as in pars. 5068-B2, 5068-B3, and 5068-B4, travel to a selected home must be completed within 1 year after active duty termination. Par 5068-B-4a: An extension of the 1-year time limit may be authorized/approved by the Secretarial Process for a period NTE six years when an unexpected event beyond the member's control prevents the member from moving to the HOS within the specified time.

IMPORTANT INFORMATION: If you already have executed your retirement transportation entitlement prior to any request or approved extension received, any move under Government expense is going to be declined. In case any additional move (using the retirement order) is erroneously executed, all cost is the responsibility of the retiree. The cost will be collected automatically by the Defense Finance and Accounting Service.
